- Fees are paid through:
 - Any branch of The Co-operative Bank of Kenya, Account Number 01129062663600, Karen branch, or M-Pesa paybill Number: 728176, Account number is the registration number for the student.
 - b. Any branch of Equity Bank of Kenya, Account Number 1250277107862, Karen Supreme branch. The university will not accept cash payment and personal cheques. All cheques and forwarding letters from CDFs', County funds and other sponsors to be brought/delivered to the University.
- 2. **Accommodation** is not guaranteed by the university. **The fee payable is Kshs.12,000/= per semester**. This must be paid in the bank by students who wish to be accommodated. There are limited accommodation facilities that will be offered on first come first served basis.
- 3. Fees once paid are NOT refundable or transferable.
- 4. Fees payment plan; full fees payment on registration day or in two installments, 50% of the fees on registration day and the balance of 50%by the 8th week of the semester.
- Graduation fee, gown and alumni fee are payable before graduation and is therefore not included in the fee structure
- 6. Attachment fees will be paid by students required to undertake attachment as specified in the curriculum.
- 7. Foreign students (Non East-African) to pay 20% more of the tuition fees.
